Q: How do we want to set (this) chapter up?

A: geography – southern chapter primarily in Ashland, MA & south (e.g. R.I.)

- this location has been the site of previous train shows (future availability to be determined)
- situated in tax free NH (no messing around with State Department of Revenue as in MA

Q: How publicize shows?

- noted Windham (NH) & Haverhill (MA) shows are gone
- TCA constantly getting smaller
- allow outsiders to have tables at shows? up to us.
- Have a (local) radio station broadcast from show?
- Charge \$5 admission; under age 5 (?) free? \$5 per family?
- Have something for kids (at shows? Within the club?)
- Recruit members? Problem for other groups. Use open house? Other ways?

Ed Young suggested we introduce ourselves (those attending), where from, bit about, etc. Noted those attending from:

MA - Burlington, Lowell, Rockport

ME – Old Orchard Beach, Otisfield, Saco

NH – Atkinson, Hudson, N. Hampton, Plaistow, Portsmouth, Rollinsford, Stratham

Q: how do we relate to/with NETCA?

A: we will be a chapter (northern chapter) within a division (NETCA). We will have our own Board of Directors (BOD) from which the president has to attend NETCA Directors meetings. We must abide by the ByLaws that were approved by TCA all else is up to us.

Advertising for shows

- noted membership lacking will limit "word of mouth"
- shows noted as success (e.g. Augusta, ME) (should we contact them for suggestions?)
- flyers at other shows/auctions?
- community bulletin boards (note WMUR-TV has one)
- TCA Blast broadcast to all NETCA members
- local bulletin boards (grocery stores, et. al.) should be short/quick read
- activities in newspapers (can get to be expensive, benefit unsure)
- target specialized groups other train clubs, shows/auctions (again)
- base of members present (e.g. Maine 3 Railers & Metro Hi Railers)
- Weather channel crawler w/intermittent announcements
- promote among train people
- Down Easter promo (reciprocating)
- 470 Club (Seashore Trolley Museum)
- Conway Scenic Railway
- Hobo Railway

Ed Young made motion no one get paid for office; motion seconded and unanimously passed.

- Noted that no dues to belong to NETCA (must be a TCA member, but NETCA gets no dues from them)
- Suggested no dues to belong to Northern Chapter

Q: what officers (Board of Directors) are required?

A: President, President Elect (to become president next year), Secretary, Treasurer & Meet Coordinator.

Q: is there a provision for 2 Board of Directors (at large)?

A: Yes; provision for 2 past presidents OR current President may appoint them.

Mentioned that no one shall have more than 1 vote.
